- Update references to Committees of Council and other references to reflect the changes to Student Officer roles and responsibilities.
- Assign overall responsibility for environmental and sustainability activities to the Executive Management Committee who shall assign special responsibilities to individual Student Officers on an annual basis.
- Assign overall responsibility for equality, diversity, fair representation, equitable access to Union services, and Equal Opportunities to the Executive Management Committee who shall assign special responsibilities to individual Student Officers on an annual basis.
- Assign overall responsibility maintaining contacts with trade unions, voluntary and community organisations with which the Union has an official membership or partnership to the Executive Management Committee who shall assign special responsibilities to individual Student Officers on an annual basis.
- Minor amendments to individual officer roles to reflect remove outdated references and reallocate some responsibilities amongst the roles.
- Replace references to non-existent staff role of Entertainments Manager with Director of the Students' Union
- Formally assign responsibility for participation in University panels (academic appeals, student conduct, academic offences and student complaints) to all Full-Time Student Officers.
- Clarify as stated in the Constitutional Student Officer Protocol that Full-Time Student Officers may not be hold Executive Committee posts in a Club or Society.

- 5.4 Shall have overall responsibility for the coordination of student development, including clubs and societies, enterprise, employability and volunteering activities, within the Students' Union, in liaison with the President and relevant Students' Union staff, and shall seek to engage students with related opportunities that exist within the Union, to include the Freshers' Fair and training events for Clubs and Societies. Shall, in partnership with Students' Union staff, provide advice and support to Clubs and Societies with regards to the terms set out in Rule 8.

- 5.5 Shall be responsible, insofar as it is possible, for ensuring that, as stipulated within Rule 8, public statements by a Society have the approval of the Union President and are not contrary to the terms and spirit of the Constitution.
- 5.6 Shall be responsible for fostering and developing an inclusive and diverse sense of community, among the Student Membership within the Union and across the University, in partnership with relevant University departments.
- 5.7 Shall work in association with the RAG organisation in order to assist with the execution of this body's duties and shall act as Treasurer of the Rag organisation.
- 5.8 Shall be responsible for campaigns and initiatives related to sustainability and environmental activism within the Union, the University and wider society.
- 5.9 Shall be a member of all relevant University Committees and groups.

Shall encourage a sense of community and promote greater involvement by the recognised Clubs, Societies and Student Associations in Union affairs.

Shall seek to engender a campaigning spirit within the Student Membership and encourage student groups to engage and participate in Union campaigning activities.

Shall, in liaison with the President and relevant Students' Union staff, have responsibility for the support and development of student engagement services in the Union, including clubs and societies, enterprise, employability and volunteering activities, and shall seek to engage students with related opportunities that exist within the Union.

Shall, in partnership with Students' Union staff, provide advice and support to Clubs and Societies with regards to the terms set out in Rule 8.

Shall be responsible, insofar as it is possible, for ensuring that, as stipulated within Rule 8, public statements by a Society have the approval of the Union President and are not contrary to the terms and spirit of the Constitution.

Shall work in association with the RAG organisation in order to assist with the execution of this body's duties and shall act as liaison between the Executive Management Committee and the Rag organisation.

Shall be a member of all relevant University Committees and groups.

DELETE (Rule 4, Section 6 – THE STUDENT OFFICER EQUALITY AND DIVERSITY):

6. THE STUDENT OFFICER EQUALITY AND DIVERSITY

- 6.5 Shall develop and maintain contacts with external community and voluntary organisations or relevance under-represented or disadvantaged student groups with which the Union has an official membership or partnership.
- 6.6 Shall strive to ensure that a genuine spirit of diversity and equality of opportunity is present throughout the Students' Union and the University, and to support and represent those students who face discrimination.

- 6.7 Shall ensure that Students' Union services are accessible to all students, maintain communications with under-represented or disadvantaged groups and draw attention to instances of discriminatory behaviour within the Union and the University whenever these occur.
- 6.8 Shall work in partnership with the Student Officer Campaigns and Engagement on campaigns related to equality and diversity.

Shall liaise with University Authorities and students to develop a positive culture of academic community within the University.

Shall, insofar as it is possible, be concerned with the general issues of transfer of courses, university scholarships, and learning supports, study skills, academic regulations and quality assurance, student academic progression and attainment, digital learning, careers services, and institutional education strategy, with a particular focus on under-represented or disadvantaged Students.

Shall be responsible for the compilation of education-related information for publication by the Students' Union, where relevant.

Shall encourage greater involvement by the recognised Student Associations in advocating on educational matters.

Shall campaign on issues that impact upon the academic student experience of underrepresented or disadvantaged Students.

Shall be a member of all relevant University Committees and groups.

Shall be a member of all relevant University Committees and groups.

Shall work in partnership with the Student Officer Campaigns and Engagement on campaigns related to the educational experience, with a particular focus on the postgraduate student experience.

Shall be a member of all relevant University Committees and groups.

INSERT INTO (FROM RULE 4, SECTION 4 – STUDENT OFFICER POSTGRADUATE EDUCATION) and renumber existing clauses accordingly:

Shall, in partnership with the Union President and the Student Officer Campaigns and Engagement, ensure good community cohesion and shall maintain good community relations, insofar as it is possible, with Residents' Groups and Associations in the South Belfast area.

Shall work in partnership with the Student Officer Campaigns and Engagement on campaigns related to student welfare.

Shall be a member of all relevant University Committees and groups.

INSERT INTO (FROM RULE 4, SECTION 7 – STUDENT OFFICER WELFARE) and renumber existing clauses accordingly:

Shall, insofar as it is possible, represent the general interests of the Students in all matters relating to their welfare.

Shall be concerned with the general issues of accommodation and student housing; safety; mental, physical and sexual health and wellbeing for Students.

Shall be concerned with the general issues of financial hardship, student support financing, and legal aid.

Shall be responsible for the compilation of welfare-related information for publication by the Students' Union, where relevant.

Shall, in partnership with the Union President, ensure good community cohesion and shall maintain good community relations, insofar as it is possible, with Residents' Groups and Associations in the South Belfast area. Shall act as the Students' Union's primary point of contact for such Groups and Associations and shall be responsible for ensuring that the Union is represented at all meetings to which an invitation has been received.

Shall be a member of all relevant University Committees and groups.

Administrative Amendments

Replace references to non-existent staff role of Entertainments Manager with Director of the Students' Union

DELETE (FROM Rule 4, Section 1 – THE EXECUTIVE MANAGEMENT COMMITTEE, 1.26):

The Executive Management Committee shall be responsible, in conjunction with the Entertainments Manager, for the provision of student-focused entertainments at competitive prices in a safe environment.

REPLACE WITH:

The Executive Management Committee shall be responsible, in conjunction with the Director of the Students' Union, for the provision of student-focused entertainments at competitive prices in a safe environment.

Formally assign responsibility for participation in University panels (academic appeals, student conduct, academic offences and student complaints) to all Full-Time Student Officers.

INSERT A NEW CLAUSE (INTO RULE 4, Section 1 – THE EXECUTIVE MANAGEMENT COMMITTEE) and renumber existing clauses accordingly:

Each Executive Management Committee Officer shall take an active role participating in University panels relating to academic appeals, student conduct, academic offences and student complaints, and in supporting students engaged with these processes.

Clarify – as stated in the Constitutional Student Officer Protocol – that Full-Time Student Officers may not hold Executive Committee posts in a Club or Society.

Shall not act as Secretary or Treasurer of any Sporting Club or Non-Sporting Society.

A Sabbatical Officer of the Executive Management Committee elected by the Student Membership shall not act as Secretary or Treasurer of any Sporting Club or Non-Sporting Society.

INSERT (A NEW RULE – TRANSITORY ARRANGEMENTS) and renumber existing Rules accordingly:

TRANSITORY ARRANGEMENTS

1. TRANSITORY ARRANGEMENTS

- 1.1 All members of the Executive Management Committee in post on the date of amendments entering into force shall continue in their posts with the titles, duties and responsibilities as enacted on the date of their commencing in post until the end of their term of office.
- 1.2 These transitory arrangements shall have no standing from the first working day of July 2025 and shall be expunded from the Constitution on the first working day of July 2025.

Enabling Motion (Constitutional Consistency)

Enabling motion to rename, reorder and renumber Constitutional clauses, and remove invalid references, as appropriate, to reflect the amendments approved by Council.

This motion shall be deemed to have been moved and approved if any Constitutional amendment at this meeting is moved and carried

Constitutional Amendment Motion:

"This Council empowers the Clerk of Council to rename, reorder and renumber Constitutional clauses, and remove invalid references, as appropriate, to reflect the amendments approved by the Statutory Meeting of the Students' Union Council, held on 3 December 2024."

Enabling Motion (Referendum)

Enabling motion to conduct a Referendum on to ratify Constitutional amendments approved at the Statutory Meeting of Council.

This motion shall be deemed to have been moved and approved if any Constitutional amendment at this meeting is moved and carried.

Referendum Motion:

"A Referendum shall take place, via by a secret ballot of all student members on q-su.org, on by end of the Teaching Week period in December 2022, at a date and time to be determined by the Returning Officer.

The purpose of this Referendum shall be to ratify those amendments to the Students' Union Constitution and its Rules that have been approved by the Students' Union Council during the Statutory Meeting of the Students' Union Council, held on 3 December 2024"
